Instructions for completing Permit Application

1. Permit Number at the top right, leave blank, this is for the Township use only.
2. *Applicant* – In proceedings involving applications for permission or authorization which the agency may give under statutory or other authority delegated to it, the parties on whose behalf the applications are made. Have applicant state which company they are working for.
3. Check box for Weight Limit or Size Restriction.
4. Check highway or bridge.
5. Posted restriction of weight or size, include units such as tons, feet, inches, etc.
6. Location, place Bridge ID number or between nearest two intersections, attach a map of Subject Bridge.
7. Place Local Route#
8. *Number of trips* – The permit may authorize a single trip, a limited number of trips during a 12 month period, or an unlimited number of trips during a period not to exceed three months. The applicant can choose one of the above and dates the move begins and ends on.
9. *Administrative Fees* - An administrative fee will be charged for the issuance of each permit and a check for the application fee shall be included with the application. For bridges on State-designated highways, the fee shall be \$15.00 for a single trip – once in each direction – or a \$50.00 for a limited number of trips during a 12 month period or an unlimited number of trips during a period not to exceed three months. Fees for permits to use bridges under the jurisdiction of local authorities shall not be greater than those charged by the Pennsylvania Department of Transportation.
10. Gross weight, total length, total width, total height, type, load, equip. /axles, truck license/state and trailer license/state must be filled in completely.
11. Next section is to be completed for bridges only.
 - a. Axle weight due to vehicle only – weigh the truck empty
 - b. Total axle weight due to vehicle and load – weigh the truck with load
 - c. Manufacturer’s Rated Axle Capacity – self explanatory
 - d. Distance from previous axle – measure center to center of tire along length of vehicle
 - e. Width of axle (center to center wheel or group) – measure transversely left to right looking at the back or front of vehicle.
 - f. Number of tires – number of tires on axle
 - g. Pneumatic Tire Width – width of each tire in inches. Vehicle code limits load to less than 800 pounds per inch of tire width (total axle weight due to vehicle and load) / (Number of tires x Pneumatic Tire width).
12. Insurance company name, Policy number, effective period, public liability, property damage and the applicant’s signature is required in the next section.
13. *Liability* – The permittee shall be liable for any damage to the bridge as well as any personal injury or property damage and shall provide such insurance or security as the posting authority may require to guarantee payment of any damage to the bridge or to persons and property who or which may be injured as a result of the permitted use. Permit applicant enters coverage from insurance policy (must be less than what you require).
14. If the load passes the analysis check, fill out bottom of application including Permit Issuance and Expiration Date and signatures by. Maintain a copy of each application for your files.
